He did ask for discussion, question, comments or concerns.

If there are no more questions this public hearing on the new wastewater rates is now over.

Mayor Steve Crosswhite called for a motion for the first reading of Bill number 04262021 by title only.

Alderman Kyle Schultz moved that Bill Number 04262021 be given its first reading by title only seconded by Alderman Stan Robinson with four in favor.

Mayor Steve Crosswhite reads Bill number 04262021 for the first time by title only.

Bill No. 04262021 An Ordinance Repealing Section 700.140 of the Sturgeon City Code and replacing it with a new section 700.140 of the Sturgeon City Code Establishing the water meter availability fee, water rate, and sewer rate effective June 15, 2021 for the City of Sturgeon

Mayor Steve Crosswhite called for a motion for Bill No. 04262021 be given its second reading.

Bill No. 04262021 An Ordinance Repealing Section 700.140 of the Sturgeon City Code and replacing it with a new section 700.140 of the Sturgeon City Code Establishing the water meter availability fee, water rate, and sewer rate effective June 15, 2021 For the City of Sturgeon

City Clerk Donna Tracy moved that Bill Number 04262021 be passed and adopted by roll call vote.

City Clerk Donna Tracy asked that Bill Number 04262021 shall now be Ordinance Number 931

AN ORDINANCE REPEALING SECTION 700.140 OF THE STURGEON CITY CODE AND REPLACING IT WITH A NEW SECTION 700.140 OF THE STURGEON CITY CODE ESTABLISHING THE WATER METER AVAILABILITY FEE, WATER RATE, AND SEWER RATE EFFECTIVE JUNE 15, 2021 FOR THE CITY OF STURGEON MISSOURI.

WHEREAS, the Board of Aldermen have evaluated the current water meter availability fee, current water rates, and current sewer rates in the City of Sturgeon and have determined that an increase in the current fees is required to cover the cost and current operation of the system.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE CITY OF STURGEON, MISSOURI, TO WIT:

Section 1. That Section 700.140, Use Rate Structure is hereby changed, altered, and amended to read as follows:

- A. Each user shall pay for the services provided by the City based on his/her use of the waterworks and sewage system, as determined by water meter(s) acceptable to the City.
- B. If a customer uses water which is not returned to the wastewater collection system, they have the option to purchase, install and maintain a separate water meter at their expense. Such as watering the garden, lawn irrigation and filling swimming pool.
- C. Water Rates.
 - 1. ¾ inch meter: The minimum availability fee for water for a ¾ inch meter shall be \$19.00 for the first 1,000 gallons of water usage. The water rate after that will be \$8.50 per 1,000 gallons, or part thereof of water usage.
 - 2. 1 inch meter: The minimum availability fee for water for a one-inch meter shall be \$33.00 for the first 1,000 gallons of water usage. The water rate after that will be \$8.50 per 1,000 gallons, or part thereof of water usage.
 - 3. 1 ½ inch meter: The minimum availability fee for water for a one and half inch meter shall be \$64.00 for the first 1,000 gallons of water usage. The water rate after that will be \$8.50 per 1,000 gallons, or part thereof of water usage.
 - 4. 2 inch meter: The minimum availability fee for water for a two inch meter shall be \$102.00 for the first 1,000 gallons of water usage. The water rate after that will be \$8.50 per 1,000 gallons, or part thereof of water usage.
 - 5. 3 inch meter: The minimum availability fee for water for a three inch meter shall be

\$202.00 for the first 1,000 gallons of water usage. The water rate after that will be \$8.50 per 1,000 gallons, or part thereof of water usage.

- 6. 4 inch meter: The minimum availability fee for water for a four inch meter shall be \$315.00 for the first 1,000 gallons of water usage. The water rate after that will be \$8.50 per 1,000 gallons, or part thereof of water usage.
- 7. Any meter size above four-inch meter will be decided at the time of construction.
- 8. The rate per gallon after the first 1,000 gallons shall automatically increase at a rate of twenty-five cents per year beginning on June 15, 2021 through June 15, 2025. Rates will be reviewed yearly thereafter.
- 9. Each customer and user who receives water to be used on property located outside the City limits shall pay a premium rate of 50% in excess of the rate charged for use inside the City limits.
- 10. In addition, each customer and user shall be charged a monthly meter fee of \$1.00 per month per meter.
- D. Sewer Rates. The minimum availability fee for sewer shall be \$20.00 for the first 1,000 gallons. The sewer rate after that shall be \$6.00 per 1,000 gallons of usage. The rate per gallon after the first 1,000 gallons shall automatically increase at a rate of fifty cents per year beginning on June 15, 2022 through June 15, 2026. Rates will be reviewed yearly thereafter. The minimum fee for each commercial or industrial sewer customer shall be not less than the fee for 6,500 gallons of usage. Each customer and user who is connected to the water and sewer system on property located outside the City limits shall pay a premium rate of 50% in excess of the rate charged for use inside the City limits. Each customer and user who is connect to the sewer system, but not the water system, on property locate outside the City limits shall pay a fee for 6,500 gallons of usage.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. This Ordinance shall take effect June 15, 2021 and be in force from and after its passage by the Board of Alderman and approval by the Mayor of the City of Sturgeon, Missouri.

Section 4. All other ordinances in conflict are hereby repealed.

AN ORDINANCE AMENDING CHAPTER 135 BOARDS, COMMISSIONS AND COMMITTEES, ARTICLE III WETLANDS IMPROVEMENT ADVISORY COMMITTEE OF THE STURGEON CITY CODE

BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE CITY OF STURGEON, MISSOURI, TO WIT:

Section 1. That Article III Wetlands Improvement Advisory Committee is hereby changed, altered, and amended to read as follows:

- Article III Wetlands Improvement & City-Wide Infrastructure Advisory Committee
- Section 135.130 Establishment of Wetlands Improvement & City-Wide Infrastructure Advisory Committee; Primary Authority.

There is hereby established a Wetlands Improvement & City-Wide Infrastructure Advisory Committee. Said committee shall be comprised of three (3) up to five (5) members residing in the Sturgeon School District, which can include City elected officials and City employees, and which shall have no term of office. The Mayor, with the consent and approval of a majority of the members of the Board of Aldermen, shall appoint such committee members. The primary authority of the Committee is to make recommendations to the Board of Aldermen about possible City wetlands improvements and city infrastructure improvements.

Section 135.140 Vacancies, Removal from Office, Reimbursement For Expenses.

- A. A new Committee member may be appointed by the Mayor with the consent and approval of a majority of the members of the Board of Aldermen to replace an existing Committee member who shall have died, resigned, been removed or when there otherwise is a vacancy in such office.
- B. The Mayor may, with the consent and approval of a majority of the members of the Board of Aldermen, remove any member of the Wetlands Improvement & City-Wide Infrastructure Advisory Committee for misconduct or neglect of duty.
- C. No member of the Committee shall receive compensation for serving on such committee, however, the Board of Aldermen shall have the authority, by adopted motion, to reimburse any Committee member for reasonable, authorized and necessary specified expenses incurred in the performance of the Committee member's duties.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. This ordinance shall take effect and be in full force and effect from and after the date of its passage and approval.

Section 4. All other ordinances in conflict are hereby repealed.

City Clerk Donna Tracy asked that Bill Number 04262021-2 shall now be Ordinance 933.

AN ORDINANCE REPEALING SECTION 700.080 OF THE STURGEON CITY CODE AND REPLACING IT WITH A NEW SECTION 700.080 OF THE STURGEON CITY CODE ESTABLISHING METER DEPOSITS; METER CONNECTIONS EFFECTIVE JUNE 15, 2021 FOR THE CITY OF STURGEON MISSOURI.

WHEREAS, the Board of Aldermen have evaluated the current meter deposits and meter connections in the City of Sturgeon and have determined that an increase in the current fees is required to cover the cost and current operation of the system.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE CITY OF STURGEON, MISSOURI, AS FOLLOWS:

Section 1. That Section 700.080, Meter Deposits; Meter Connections is hereby changed, altered, and amended to read as follows:

- A. Whenever any dwelling or any lot, parcel of land shall become connected to the system either for water services or sewage services, a meter deposit of one hundred fifty dollars (\$150.00) shall be made.
- B. Whenever any dwelling or any lot, parcel of land or premises shall become connected to the waterworks and sewage system of the City, the following connection charges shall be imposed (to include, but not limited to, lots that may have an old water meter connection that does not have a backflow device):
 - 1. When connecting to polyvinyl chloride (PVC) or asbestos cement (AC) water main three-fourths-inch pipe, one thousand dollars (\$1,000.00) for connections on the same side of the road as the water main and one thousand five hundred dollars (\$1,500.00) for connections on the opposite side of the road of the water main.
 - 2. When connecting to any City main, a water-metering system larger than three-fourths (3/4) inch, an additional fee equal to the costs of materials and labor shall be imposed.
 - 3. When connecting from a lot, parcel of land or premises within the water service boundary area of another waterworks, an additional fee equal to the charge from the other waterworks to authorize the City to serve, provide, and sell water shall be imposed.
 - 4. Sewer permit: Inside City Limits: one thousand five hundred dollars (\$1,500.00); Outside City Limits: seven thousand five hundred dollars (\$7,500).
 - 5. If any fees imposed pursuant to this Section remain unpaid on the 21st of the month, the water supply for the lot, parcel of land, or premises affected shall be disconnected and a fifty-dollar (\$50.00) disconnect fee will be added to the delinquent bill, as well as a fifty-dollar (\$50.00) fee for reconnection.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. This Ordinance shall take effect June 15, 2021 and be in force from and after its passage by the Board of Alderman and approval by the Mayor of the City of Sturgeon, Missouri.

Section 4. All other ordinances in conflict are hereby repealed. Old Business:

Ordinance 798 & City Code 135.130 – Infrastructure Committee Mayor Steve Crosswhite ask the Board to approve: Mark Perkins, John Gingerich, Ashley Long, Buster Adkisson and Zane Arends to be on the Infrastructure Committee.

Alderman Stan Robinson made a motion to have these five people form the Infrastructure Committee for the City of Sturgeon. The motion was seconded by Alderman Kyle Schultz with four in favor.

Mayor explain the City of Sturgeon does owe Public District Water #10 \$10,558.80 for hook-ups at Sterling Meadows. We do not have a line item in the 2020-2021 budget would the Council be ok to pay this bill in July 2021 and put this expense in the new budget. Yes, the Council said yes that would be fine.

Review bids for park & youth building work Mayor Crosswhite said there were no bids to do the work at the park or youth building. Ask the Council what they wanted to do at this point they all said table it until a later date.

Budget worksheets for fiscal year 2021 – 2022. Mayor Steve Crosswhite did remind all Council members they have their worksheets and what groups they should be working with.

American Rescue Plan information Mayor Crosswhite told the Council he has been listening to different webinars on the subject they will release the details soon.

Downtown Light Pole City Attorney said it will cost more to prosecute the woman who ran over the pole than it is worth it is in the best interest of the City to drop it and move on.

City Personnel Policy is now ready to pass. Alderman Stan Robinson made a motion to accept the City Personnel Policy accepting the edits. The motion was second by Alderman Ashley Long with four in favor. Be noted the City Personnel Policy is updated and approved on April 26, 2021

Also, the City Attorney did announce to the Mayor and Council the rates for his services will be going up.

Maintenance Department: John Gingerich said Socket is in town they keep hitting water lines also a lot of locates the last four weeks this has taken up a lot of time.

They have worked with Matt Cope cutting down trees for the City. Thomas, Steve Crosswhite, Zane Arends and himself all worked at removing the brush.

The sand and cold mix project is complete they built a place to store the sand and the cold mix at the shop.

John did say they are discharging at Danny Kyle's pond. He did say they met with Gary Cunningham and he did a study showing we have a gaining stream for which is good news.

They did interview two different people for the mowing job here in Sturgeon both applicants did say they want \$13.00 an hour. The Council said no they don't want to pay that much they did ask Brian Perry if he could extend his contract and take over more of the mowing for the City.

The question did come up about the burn pile why does the road have to go so far back. If the burn pile could be closer to the road, it would save the City a lot of money. Also, John will measure to see where the nearest house is. It needs to be 600 feet away from the burn pile. Mayor Mike Butler said we should ask the people who live around the area what they think.

City Attorney Jackie Rodgers: Went over the Administrative Internal Control Policy with the new Mayor and Council. The highlights are anything \$500.00 or less the department head can buy it. Purchases from \$501.00 to \$4,999.00 if the budget allows the department head must get three quotes. If you can't get three quotes then ask the Mayor for approval. If the budget does not allow then two Alderman and the Mayor must approve the purchase. Purchase of \$5,000.00 needs to be in the budget.

City Attorney Jackie Rodgers said the Purchasing Policy & Guidelines for the City of Sturgeon is for the general public when the City is going out for bids for a City Project.

City Attorney Jackie also announce he will be raising his rates when his contract is up for renewal.
